## Basic Wedding Package Contract

1. **PACKAGE:** The Basic wedding package consists of 3-4 hours of wedding coverage. Which includes, the first time the bride and groom meet at the ceremony, ceremony coverage, formal portraits with or without studio backdrop and studio lighting, large group portraits, environmental portraits weather permitting, toasts, cake portraits and cake cutting series. After all photos have been edited the photos will be displayed publicly or privately for you viewing. You will also receive a 11x14 proof book of all photos 1-8x10 6-5x7's and 30-4x6's. All additional items are a la carte.

2. **LIMIT OF LIABILITY:** Our loss or damages of negatives or electronic capture is limited to the return of all deposits made. Quantity and quality of coverage is affected by cooperation of couple and their guests. Upon signature, we reserve the time and date agreed upon. For this reason, all deposits are non-refundable, even if the wedding date is changed or cancelled for any reason. If the Photographer is not state side for the projected wedding date for unexpected reasons the deposit will be refunded and this contract null and void.

3. **EXCLUSIVE PHOTOGRAPHER:** It is understood that no other photographer, amateur or professional, shall be allowed to photograph at the wedding while the Photographer is working, and that any breach of this agreement will constitute a reason for non-completion of the job with no liability to the Photographer and loss of Reservation Deposit by Client.

4. **GUARANTEED DELIVERY TIME:** Picture It Photography agrees to have the contracted order for wedding photographs completed within 3-4 weeks from the date ordered of the selected photos from the Wedding Package. Also any other photographic orders will be completed within 4 weeks of their order placement. This guaranteed delivery time is dependent upon Photographer being stateside.

5. **DISPLAY PROMOTION:** It is agreed that the Photographer may display and use photographs from Wedding Day for advertising, display, web sites and internet promotion, photographic contests, bridal shows, public display as in malls, photography books, photography instructional books, store fronts, window displays, studio display, television advertising, magazine advertising and any other purposes thought proper by the Photographer or Picture It Photography.

6. **COPYRIGHTS:** All images produced by Picture It Photography are copyright protected by U.S. Copyright Laws, and any attempt to copy in any way is strictly prohibited. This includes copying by photographic process, photocopier, digital process, or by scanning into a computer. Any such attempt is considered breach of contract.
